NOTICE OF PERMANENT SPEED RESTRICTION
(A525 DENBIGH GREEN)
(30 MPH SPEED RESTRICTION) ORDER 202

Denbighshire County Council hereby gives notice that it proposes to make an Order under Sections 82(2) 83(2) 84(1) and 84(2) and Part III and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of the Order will be to impose a 30 miles per hour speed limit on the length of road specified in the Schedule below.

The previously made Order entitled Denbighshire County Council (Denbigh Green, Denbigh) (40 mph Speed Restriction) Order 1998 will be revoked in so far as it affects the length of road described in the Schedule below.

Copies of the proposed Order with plans, and order to be revoked, and statement of the Council's reasons for proposing to make the Order may be examined at Denbigh Library, Hall Square Denbigh during normal opening hours, and at the Council's offices at Caledfryn, Smithfield Road, Denbigh.

Any person wishing to object to the proposed Order should do so either by submitting responses to a questionnaire, to which the proposals relate, using Denbighshire County Council's website under County Conversation Portal, or by sending a written statement of objection, stating the grounds on which the objection is made to the Head of Legal HR and Democratic Services, Denbighshire County Council, PO Box 62, Ruthin LL15 9AZ, by no later than 17th April 2020. Please note that the substance of any representations the council receives could become available for public inspection.

Statement of Reasons.

To implement the findings of the speed limit review for the County following the Welsh Assembly Government Circular 24/2009 which set a target for areas to review and where appropriate implement changes along all A & B roads in the area.

(30 mph Speed Restriction) Order 202

1. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour on the length of road specified in the Schedule hereto
2. The previously made Order entitled Denbighshire County Council (Denbigh Green, Denbigh) (40 mph Speed Restriction) Order 1998 is hereby revoked in so far as it affects the length of road described in the Schedule
3. This Order shall come into operation on 202 and may be cited as Denbighshire County Council (A525 Denbigh Green) (30 mph Speed Restriction) Order 202
