

**DENBIGHSHIRE COUNTY COUNCIL**  
**(VARIOUS ROADS) (30MPH SPEED LIMITS) ORDER 2023**

Denbighshire County Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 82, 83 and 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) as amended, and of all other enabling powers and after consultation with the Chief Officer of Police and in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

**SECTION 1 – PRELIMINARY**

1. This Order shall come into operation of the **XXX** day of **YYY** 2023 and may be cited as the Denbighshire County Council (Various Roads) (30mph speed limits) Order 2023.
2. The Denbighshire County Council (Various Roads) (30mph speed limits) Order 2023 plans (hereinafter referred to as “the Plans” listed in the Schedule 1 are incorporated in to this Order.
3. “The Plan Index” forms Schedule 2 to this Order.
4. No Person shall drive any Motor Vehicle at a speed exceeding 30mph on the lengths of roads specified in the Plans in Schedule 1 to this Order
5. The Provisions of Article 4 shall not apply to any vehicle on any occasion when it is being used for ambulance service, fire service, or police purposes if the observance of that provision would be likely to hinder the use of the vehicle for the purpose which it being used on that occasion.
6. In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes in to operation, the provisions of this Order shall prevail.

7. In this Order except where the context otherwise requires, “motor vehicle” has the same meaning as in Section 136 of the Act.

**STATEMENT OF REASONS FOR PROPOSING**  
**(VARIOUS ROADS) (30MPH SPEED LIMITS) ORDER 2023**

**Denbighshire County Council (Various Roads) (30mph speed limits) Order 2023.**

The Senedd has approved legislation to lower the default national speed limit on restricted roads from 30mph to 20mph to reduce the number and severity of collisions and casualties, to enable more people to use active travel, to reduce environmental impacts and to improve people's quality of life in communities across Wales.

The Restricted Roads (20mph Speed Limit) (Wales) Order 2022 was made by Welsh Ministers on 13 July 2022 and will come in to force on the 17<sup>th</sup> of September 2023. From that date any restricted road will have a speed limit of 20mph unless a different speed limit is set by the highway authority by Order.

Highway Authorities, through evidence based decisions, are enabled to introduce exceptions to this default speed limit by making speed limit Orders that will retain the current 30mph speed limit.

Following a thorough review of their highway network, in line with Government issued guidance, Denbighshire County Council has identified five locations where exceptions Orders to the default speed limit can be safely made, reflecting local needs and considerations and to allow free flow of traffic by retaining the current 30mph speed limits.

A recent consultation with the North Wales police and the local elected members who cover the area highlighted support for these proposals

Therefore, it appears to the County Council as Order making Authority, that it is necessary and expedient to make the above exceptions Order in the interests of users of the Denbighshire highway network.

**NOTICE IS HEREBY GIVEN** that Denbighshire County Council ("the Council") in exercise of its powers under Sections 82, 83 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and after consultation with the Chief Officer of Police proposes to make the above-named Order, the effect of which will be as follows:

- a) To introduce a 30 mph speed limit on various roads in Denbighshire as detailed on the plans attached to the Order, affecting the Prestatyn, St. Asaph, Ruthin, Llanfwrog, and Rhyl areas
- b) To revoke existing speed limit orders where they overlap any part of the proposals to this Order as detailed on the plans attached to the Order.


